<u>To enroll</u>: Fill out our registration form along with your <u>\$125 non-refundable annual registration fee per student</u> and return to St. Bernard's School. Once you submit your registration form and registration fee, we will contact you about our registration packet.

<u>Multiple Child Discount</u>: A 10% discount is applied for two or more siblings enrolled. Discount is applied to the lower tuition rate.

<u>Tuition/Absences</u>: Tuition is paid through FACTs tuition. Please complete your online registration as early as possible. All tuition is due regardless of sickness, behavioral/disciplinary removal, vacations, holidays, emergency related closings mandated by the state/local government, like a pandemic. Any tuition Refunds for families that leave during the school year will be at the discretion of the Director.

**Hours:** Monday through Friday, 7am until 5:30pm. No children will be allowed into the preschool before 7am. Failure to pick up your child by 5:30pm will result in a late charge at a rate of \$10 flat for the first five minutes and \$2 for each minute thereafter. Payment for late pick-up will be due immediately with payment submitted before the child returns to care.

<u>Withdrawals:</u> Parents may withdraw a child from the program at any time. A 30-day written notice must be submitted to the center prior to removing your child from the program. Parents are required to pay tuition fees for the entire 30 days, even if your child does not attend.

**Classroom Placement:** St. Bernard's Catholic Preschool offers a toddler program (2-3 years), preschool program (3-4 years), and pre-kindergarten program (4-5 years). Students must be 2 years of age on or before September 1<sup>st</sup> to enter into the toddler program and 3 years of age on or before September 1<sup>st</sup> to enter into the preschool program. Students must be 4 years of age on or before September 1<sup>st</sup> to enter into the pre-kindergarten program. It is not necessary for students to be potty trained to attend our toddler program, however for the older groups it is a requirement by the first day of school.

**Potty Training Fee:** Our potty training fee is \$40/month for all children who are still using pull-ups until they become fully potty trained. Families will provide pull-ups and St. Bernard's will provide wipes. We will inform you when you are running low on any products. These items will be kept in a labeled bin in the bathroom.

**Termination:** The Director may recommend the transfer of student or parent: 1) the safety and security of the children and staff in our program is compromised by the student's attendance. 2) The needs of the student cannot be met by our program and/or the student will not benefit from continued attendance in our program. 3) Failure to meet the financial obligations of our program with which he or she accepted upon enrolling his/her child into the program. 4) A parent or guardian has been uncooperative with the preschool's staff, program policies, procedures, or state regulations.

**<u>Respectful Treatment</u>**: It is expected that children and parents will be treated respectfully and with dignity by St. Bernard's Catholic Preschool staff. It is also expected that center staff is treated respectfully and with dignity by parents and children.

In accordance with regulation #101200 (Inspection Authority of the Department) of the Manual of Policies and Procedures, Community Care Licensing Division, Child Care Center, Title 22, Division 12, Chapter 1 states the following:

"The Department has the authority to interview children or staff, and to inspect and audit child care center records, without prior consent. The licensee shall make provisions for private interviews with any child(ren) or staff member; and for the examination of all records relating to the operation of the child care center. The Department has the authority to observe the physical condition of the child(ren), including conditions that could indicate abuse, neglect or inappropriate placement."

#### Director's Right to amend

The Director of St. Bernard's Catholic Preschool retains the right to amend this form for just cause. Parents will be given prompt notification if changes are made. A 30-days' notice will be given to parents of any fee changes that may occur.
